

ENCOUNTER OF 2CV : THE ROAD OF GOLD INTERNAL REGULATION

ARTICLE 1 - Conditions of admission

- To penetrate, install, reside on the rally, it is necessary to fulfil a right of entry that will remain invariably during all the duration of the manifestation.
- The stay on the rally implies the acceptance of dispositions of the regulation and the commitment to conform there.
- All person having acquitted its entry right is supposed to have taken knowledge this regulation.

ARTICLE 2 - Reservations

- Rates in case of reservation are more advantageous in case of payment before 15 January of the under way year that after this date or to the welcome the day of the manifestation.
- In case of not - reservation, it will not be possible to demand an identical rate.
- If no reservation has been undertaken to the preliminary, 2cv Coast Club of Azure is not committed to what there are available places to the meal of the evening Saturday and to the gîte proposed for the night.
- 2cv Coast Club of Azure will not refund participants having reserved and that will not withdraw to less of 15 days before the date of the manifestation.

ARTICLE 3 - Installation

- In a concern of optimization of the site, participants are prayed to respect sites that are designated their.

ARTICLE 4 - Dues

- Rights of inscription are to rule on reservation or to the office of welcome and give access to the site.
- No regulation by check in euros emanating from foreign countries will be able to be accepted (regulation in cash). For foreign country reservations, we will not accept while postal mandates.

ARTICLE 5 - Animals

- Dogs and other animals do not have to be left in liberty, they will be inevitably held in leash. They do not have to be left alone, even enclosed in the absence of their master that are civilly responsible.

ARTICLE 6 - Circulation

- INSIDE the site transport them have to roll to 10km/h @@maxi and to respect the road regulations .
- The parking does not have to hinder the circulation, to prevent the installation of new arrivants, to constrict persons installed. Prohibitions of parking put in place by the organisation will have to be respected.

ARTICLE 7 - Appearance and aspect of installations

- Each is held to respect : installations stake to dispositions, the hygiene, the aspect of the site. To respect green spaces, plantations, branches of trees, enclosures.
- All degradation will be to the cost of its author.

ARTICLE 8 - Flights

- Organisers are not in the least responsible in case of flights on the site. Each participating is responsible its goods and has to signal all suspicious behaviour to the responsible of the manifestation.

ARTICLE 9 - Display

- The present internal regulation is displayed to the welcome to the point @@info and will be given to each participate.

ARTICLE 10 - Infringements

- Organisers reserve the right to exclude : all nobody having respected this internal regulation, all person disturbing the good progress of this manifestation - All person on the site has be able at any given time to prove its inscription (macaroon)
